3. That Air Force School 3 BRD is being run as community service and not as a business and that commercialization does not take place in the school in any manner whatsoever
4. That no part of income from the institution is being, and will be diverted to any individual in the ~~Trust/Society/Company/School Management Committee~~ or to any other persons/ entity. The saving, if any, after meeting the recurring and non-recurring expenditure and contributions to the developmental, depreciation and contingency funds, will be further utilized for promoting the school and extending the clause of education in the same school only.
5. That Air Force School 3 BRD is not paying any charges towards using name motto, logo or any other non- academic activities to any other institution, organization or body
6. That Air Force School 3 BRD will not open classes under CBSE pattern particularly class IX/X//XI/XII, and will not use CBSE name in any manner without obtaining affiliation.
7. That the Principal and correspondence/Manger of the School 3 BRD have individually gone through the provision contained in the affiliation & examination by laws and the circular issued be the Board from time to time. The School undertakes to abide by the provison contained in the Affiliation & examination by laws, direction issued from time to time and the law of the land.
8. That Air Force School 3 BRD will ensure compliances of all statutory requirements like EPF, ESI and labour laws etc. with respect to the school and staff of the school.

15. That Air Force School 3 BRD will ensure that the school fulfils all essential requirements before applying for affiliation and will fulfil all other condition post affiliation and comply with all the general rules as given in the affiliation byelaws or notified from time to time.
16. That in case affiliation has been with certain condition, the school will not start CBSC pattern classes without submitting a certificate/affidavit to the effect that affiliation conditions contained in affiliation byelaws along with general rules.
17. That Air Force School 3 BRD will not be sponsored from the other board.
18. That no member of the school Management Committee is related to each other.
